Cancelled visits with less than 24-hour notice will be charged at full cost of the service.

+**Transports** are pick up and drop off only. Direct or Indirect Transports. Does not include the community support worker attending your appointment with you.

***Social Support** is when the community support worker remains with you during the rostered service or appointment.

Care Management

For ongoing services, 10% is deducted from your quarterly budget to fund care management activities. These activities provide support your health, safety and over all wellbeing by providing co-ordinated services, reviewing and monitoring your care needs, reviewing your care plan. Care Management Fees will be documented in your Support At Home Statement.

Assistive Technology and Home Modifications (AT-HM)

You may be approved by a My Aged Care Assessor for separate funding for Assistive Technology and/or Home Modifications. This funding is additional to your Support at Home package and is to purchase an approved item or modification. Please speak to your Case Manager for further information.

Assistive technology includes items, pieces of equipment or products that help a participant to:

- do things more easily
- complete activities they can no longer do independently.

Examples of assistive technology include:

- mobility equipment, such as walking sticks, walking frames and wheelchairs
- toileting supports, such as bedpans and commodes
- bathing devices, such as shower chairs and bath boards

For Assistive Technology Funding Migrant Resource Centre Tasmania will charge an additional 10% or up to \$500 (whichever is less) and will be including in the total purchase price not as a separate fee.

For Home Modifications Funding Migrant Resource Centre will charge an additional 15% of the quoted cost or up to \$1,500 (whichever is less) and will be including in the total purchase price not as a separate fee.

Gardening

Support At Home funding can provide you with light gardening. Light gardening consists of lawn mowing, edging and pruning to ensure safe access to and from your home.

Consumables and other products

Products such as incontinence pads, nursing care items will be an additional fee of 10% or \$500 (whichever is lower).
